ARTICLES OF INCORPORATION REGENCY MANAGEMENT SERVICES, INC.

ARTICLE I. NAME

The name of this corporation is:

REGENCY MANAGEMENT SERVICES, INC.

ARTICLE IL PURPOSE

This corporation is organized for the following purposes:

To engage in any and all lawful business for which a corporation may be incorporated under the laws of Florida.
