ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF ACCENTIA BIOPHARMACEUTICALS, INC.

FIRST: This Corporation is named Acceptia Biopharmaceuticals, Inc. and was originally incorporated in the State of Florida on March 26, 2002, and the Corporation hereby adopts these Articles of Amendment to the Amended and Restated Articles of Incorporation of the Corporation.
