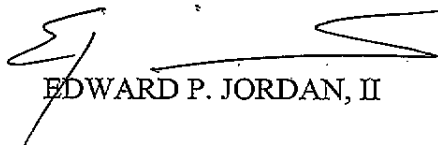

Initial Board of Directors

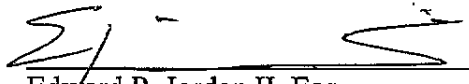

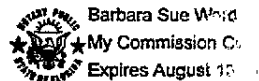
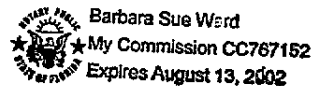
