ARTICLES OF INCORPORATION OF BAKER'S HOME IMPROVEMENTS INC

In Compliance with Chapter 607 and/or Chapter 621, F. S. (Profit)

<u> ARTICLE I - NAME</u>

The name of the corporation is BAKER'S HOME IMPROVEMENTS INC.

<u> ARTICLE II - DURATION</u>

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles or until such time law shall dissolve it.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all business not unlawful under the laws of the State of Florida or the United States of America.

ARTICLE IV - CAPITAL STOCK
