

ARTICLES OF INCORPORATION
OF
ALL STAR SPORTS BAR & GRILL OF POMPANO, INC.

ARTICLE I - NAME

The name of this corporation shall be: ALL STAR SPORTS BAR & GRILL OF POMPANO, INC.

ARTICLE II - DURATION

The principal office and mailing address of the corporation is 3677 North Powerline Road, Pompano Beach, FL 33073.


ARTICLE VIII - INCORPORATOR


