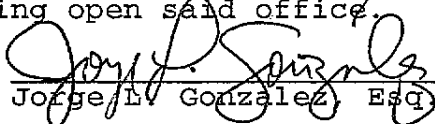
ARTICLE V. CAPITAL STOCK

ARTICLE VI. INITIAL REGISTERED AGENT AND OFFICE

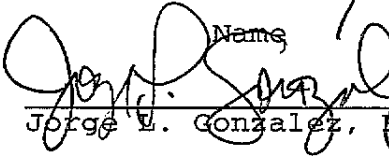

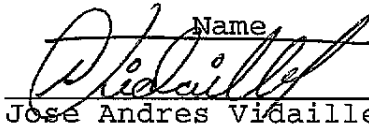

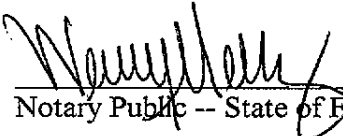
