The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: AMERICA'S FIRST WORK FORCE, INC. The address of the principal office of this corporation shall be 1200 St. Charles Pl., Suite 214C, Pembroke Pines, Florida 33026 and the mailing address of the corporation shall be P.O. Box 1571, North Miami Beach, Florida 33160.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK
