ARTICLES OF INCORPORATION

OF

DISABILITY ALLIANCE, Inc.

ARTICLES I – NAME

The name of the corporation shall be DISABILITY ALLIANCE, Inc.

ARTICLE II – DURATION

This corporation shall have perpetual existence and shall commence upon filing hereof.
