<u>ARTICLE I - NAME</u>

The name of the Corporation is: JENNIK ENTERPRISES, INC.

The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.
