ARTICLE 1

NAME

The name of this corporation is: PAT CLEVELAND, INC.

ARTICLE 2

DURATION

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is the time of the filing of the articles of incorporation by the Department of State of the State of Florida.

ARTICLE 3

GENERAL PURPOSE

The general purposes of which this corporation is initially organized are to engage in any or all lawful business for which corporation may be incorporated under Florida law. The corporation initially intends to engage in the business of construction and home repair.

CLASSIFICATION AND SHARES

The classification of the corporation is Sub-Chapter "S" Corporation. The corporation

ARTICLE 5

PRINCIPAL OFFICER AND REGISTERED AGENT

ARTICLE 7

GOVERNING BOARD

The Governing Board of this corporation shall be known as its Directors. The Directors need not be Stockholders of the corporation unless so required by the bylaws. The Board of Directors shall be elected by the Stockholders at their annual meeting, or such other times as the

bylaws may provide, and shall hold office until their successors are respectively elected and qualified. The bylaws shall specify the number of directors necessary to constitute a quorum. The Board of Directors may, by resolution (s) passed by a majority of the whole Board, designate one or more committees which to the extent provided in said resolution (s) or in the bylaws shall have and may exercise all powers of the Board of Directors on the management of the activities and affairs of the corporation and may have the power to authorize the seal of the corporation to be fixed to all papers which may require it and such committee (s) shall have such name (s) as may be stated by the bylaws of the corporation or as may be determined from time to time by the resolution adopted by the Board of Directors. The Board of Directors may elect such officers as the bylaws may specify, who shall, subject to the provisions of the Statutes, have such titles and exercise such duties as the bylaws may provide. The Board of Directors is expressly authorized to make, alter, or repeal the bylaws of this corporation or any article therein.

The number of Directors may from time to time be increased or decreased in such manner as shall be provided by the bylaws of this corporation, providing that the number of Directors conform to the Statutes of the Corporation Law of this state.

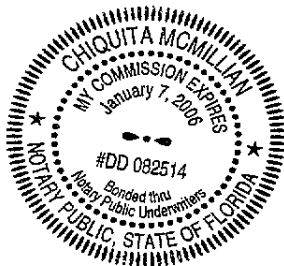
