**ARTICLES OF INCORPORATION  
OF  
DISCOUNT ALUMINUM CONSTRUCTION, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the corporation is DISCOUNT ALUMINUM CONSTRUCTION, INC.

**ARTICLE II: PRINCIPAL OFFICE**

The principal office is 610 Lake Blue, Lake Placid, Florida 33852.

**ARTICLE III: DURATION**

The duration of the corporation is perpetual.

**ARTICLE IV: PURPOSE**
