
The purpose of this letter is to explain why Family Service corp. became "inactive" according to online report at ccfcop.doc.state.fl .

In September 17 2003, I sent to my accountant Michael Torres the filled out forms that are used to notify change of addresses. Since Mr. Torres is the accountant for 2 corporations of my property, (one is "Family Service Corp." and the second one "Global Funeral Distributors" which both of them before September 2003 had the address: 7184 sw 47th street, Miami, FL 33156) he was instructed by me to send a form for "Family Service corp." and one for "Global Funeral Dist." notifying the change of address. As your records might show, your office processed the change of address for "Global Funeral" but not for "Family Service corp.", creating a vacuum in which it was impossible for me to receive any information regarding annual fees and annual reports for Family Service corp.

When you look at your records for both companies you can see they are new small business in which one of them ("Family Service Corporation) through great efforts has managed to create 3 new jobs in south Florida. My intent is to pay all fees and dues to keep this business running but ask you to please try to understand that a \$900.00 penalty to reactivate the company will be hard for us to pay. Therefore we ask you to analyze my petition to wave the \$900.00 reactivation fee, accept \$300.00 for 2003 and 2004, activate this corporation, and proceed to finalize changing "Family Service corp." mailing address to: 1323 nw 139 terrace, Pembroke Pines Florida, 33028.

Attach you will find a check for \$300.00 (\$150.00 per year) and "Corporate Reinstatement" . Also please take note that even though Mr. David Iverson appears as the registered agent for Family Service corp. at the current moment he no longer acts as the registered agent since I am no longer retaining Mr. Iverson as my lawyer .
