**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, **Shoma Homes at Bristol Park, Inc.**, a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is: **Shoma Homes at Bristol Park, Inc.** The Document Number of the Corporation is P02000034173. The filing date of the Articles of Incorporation of the Corporation was March 28, 2002.
