

### ARTICLES OF INCORPORATION OF

SHOMA VIII, INC.

in compliance with Chapter 607, Florida Statutes

## ARTICLE I - NAME OF CORPORATION:

The name of the corporation shall be: SHOMA VIII, INC.

# ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS:

The principal place of business and mailing address of the corporation is: 8550 N.W. 33 Street, Miami, Florida 33166.

### <u> ARTICLE III - CAPITAL STOCK:</u>

The corporation is authorized to have outstanding one class of stock, to be designated as Common Stock. The maximum number of shares of Common Stock which the corporation is authorized to have outstanding is 1,000 shares of Common Stock of a par value of \$.01 per share.
