**ARTICLE I. NAME**

The name of this corporation is:

**ARTICLE II. DURATION**

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

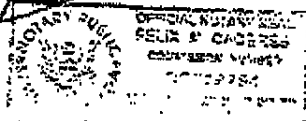

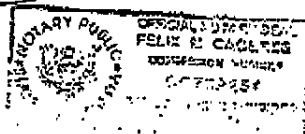
