The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation ("Corporation") shall be: ICANDY MARKETING, INC.

ARTICLE II

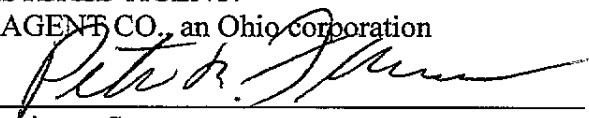
