ARTICLES OF INCORPORATION

The undersigns, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE NAME

The name of the corporation shall be Bet Construction and Roofing Services, Inc.

ARTICLE TWO PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of this corporation shall be 7325 SW 105 Terrace, Miami, Florida 33156.

ARTICLE THREE SPECIFIC PURPOSE

The general nature for which the corporation is organized are:

1. To engage in the general business of construction or remodeling of homes, commercial buildings, additions, apartments, motels, hotels, or any other structure, as a general contractor or as a roofing subcontractor, including any and all phases of said construction; the purchase, sale, development, or investment of real estate and all phases connected thereto; and advertising, financing, or any other necessary business transactions which generally flow therefrom.
2. To do such other things as incidental to the above, necessary or desirable in order to accomplish the above.

The corporation shall have all powers necessary and conferred upon corporations by the laws of the State of Florida, to do and perform all other acts which may be necessary or expedient in the proper and expeditious administration of the business of the corporation, to all intents and purposes as fully as a natural person could do and perform, and which are now or hereafter may be authorized by law.

No recitation, expression, or declaration of specific or special power and purposes herein enumerated shall be deemed to be exclusive, but all powers not inconsistent therewith are hereby declared to be included.

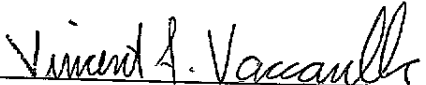
