ARTICLES OF INCORPORATION CORPORATION FOR-PROFIT A PREMIER LEASING COMPANY, INC.

In compliance with chapter 607 and/or chapter 621 of the Fla. Stat. of the state of Florida regarding corporations for-profit the undersigned incorporators do hereby organize for the purposes of incorporating Corporation for-profit as follows:
