**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is DISTRIBUTION SOLUTIONS GROUP, INC., and the principal address and principal place of business is 637 GARLAND CIRCLE, INDIAN ROCKS BEACH, FLORIDA 33785.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is c/o O'CONNOR & ASSOCIATES, 2240 Belleair Road, Suite 160, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is PATRICK M. O'CONNOR, ESQUIRE.

**ARTICLE III - PURPOSE**

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.
