**ARTICLES OF INCORPORATION
OF
FLORIDA 1ST SERVICE ADMINISTRATORS, INC.,
A Florida Business Corporation**

The undersigned, acting as incorporator of a business corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such business corporation:

ARTICLE I--NAME

The name of the business corporation shall be FLORIDA 1ST SERVICE ADMINISTRATORS, INC. (the "Corporation").

ARTICLE II--PRINCIPAL OFFICE

The principal office of the Corporation shall be 3425 Lake Alfred Road, Winter Haven, Florida 33881.

ARTICLE III--REGISTERED AGENT

The street address of the Corporation's initial registered office is 200 Avenue F, N.E., Winter Haven, Florida 33881, and the name of its initial statutory agent at such address is Lance W. Anastasio.

ARTICLE IV--DURATION

The duration of this Corporation shall be perpetual.

ARTICLE V--NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to conduct any and all lawful activities or business permitted under the laws of the United States of America and the State of Florida, (and in particular, without limitation, Chapter 607 of the Florida Statutes, entitled the Florida Business Corporation Act which is hereby incorporated by reference herein these Articles of Incorporation).

ARTICLE VI--CAPITAL STOCK

The aggregate number of shares of capital stock that the Corporation shall have authority to issue is one hundred thousand (100,000) shares, having a par value of one (\$.01) per share, designated as common stock.
