The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

#### **ARTICLE I**

#### Name and Principal Place of Business

The name of the corporation is Kok-Tow Ng, D.D.S., P.A., and the principal place of business is 4131 University Blvd. S., Bldg. 5, Jacksonville, Florida 32216.

#### ARTICLE II

#### Duration

This corporation shall exist perpetually, commencing upon the filing of these Articles with the Secretary of State of the State of Florida.

#### ARTICLE III

#### Nature of Business

This corporation is organized for the purpose of providing orthodontic dentistry.
