**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
NOVEL - TEE EXPRESS, INC.**

1. The name of this corporation is Novel - Tee Express, Inc., a Florida corporation (the "Company"), whose principal office address is c/o 700 South Federal Highway, Suite 200, Boca Raton, Florida 33432.
2. Article I, of the Articles of Incorporation of the Company is hereby deleted in its entirety and amended to read as follows:

"ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this corporation is Logo Express, Inc. Its principal office and business mailing address is 1404 S.W. 13th Court, Pompano Beach, Florida, 33069".

3. The foregoing amendment was adopted by the Written Consent of the Shareholders and Board of Directors of the Company, on April 30, 2002, in accordance with the Florida Business Corporation Act.

4. 1,000 of the Company's 20,000,000 authorized shares of Common Stock, par value \$.0001 per share, have been issued as of the date of the adoption of the amendment and all such shares voted in favor of the adoption of such amendment.
