The undersigned subscribers to these Articles of Incorporation, being

hereby form a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be REAL RECORDS, INC. The  
principal place of business of this corporation shall be 1001




