ARTICLES of INCORPORATION

of

JTransit, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name

The name of the corporation is **JTransit, Inc.**

Article IX - By-Laws


The power to adopt, alter, amend, or repeal the by-laws shall be vested in the board of directors and shareholders.
