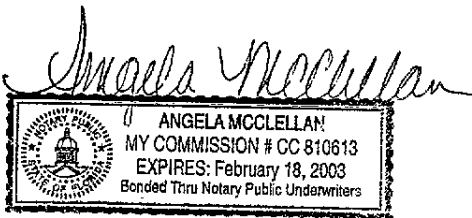

ARTICLE II

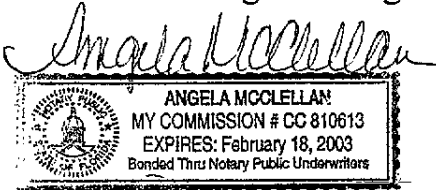
REGISTERED OFFICE AND REGISTERED AGENT: The street address of the initial registered office is 17484 Harrell Street, Brooker, FL 32622

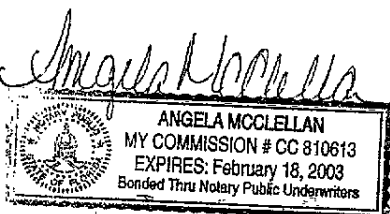
