
Dear Sir or Madam:

Rayletta, Inc. was administratively dissolved on September 19, 2003 for failure to file its Annual Report for the year 2003. I discovered this fact while researching whether any of the corporations I represent had not filed their annual report/UBR's for this year.

When I copied the report on file with your office, I learned that the Division of Corporations still had Rayletta's address as 5400 A Holmes Blvd., Holmes Beach, Florida. My client informs me that the City of Holmes Beach had officially changed the name of the street to Marina Drive and that he had obtained a post office box for mailing since Rayletta, Inc. was having problems receiving its mail. Mr. House, the President of Rayletta, Inc. does not believe he received the annual report for the year, 2003 and inadvertently, never notified the Division of Corporations of the change of Rayletta, Inc.'s mailing address from the street address to the post office box.

I have enclosed a reinstatement form for the corporation and my client's check in the amount of \$300.00 for the annual fees for 2003 and 2004. I would respectfully request that under the circumstances, the Division of Corporation waive the \$600.00 late fee and reinstate Rayletta, Inc. I would appreciate your letting my client or me know of your decision.
