ARTICLE I

Name

1.1. The name of the corporation is AARLICE SKILLED LABOR, INC.

Indemnification

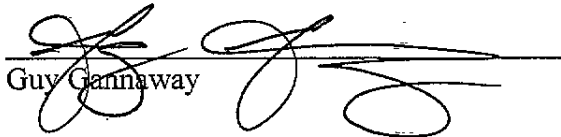
