The undersigned file these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

**ARTICLE I – NAME**

The name of the corporation shall be Jannfra Corporation (Hereinafter referred as to the “Corporation”)

**ARTICLE II – CORPORATION EXISTENCE**

The existence of this Corporation shall commence upon the filling of these Articles of Incorporation and shall continued perpetually unless dissolved according to the law.
