

Articles of Incorporation of

SR INVESTMENT GROUP, INC.

ARTICLE ONE

The name of the corporation is SR INVESTMENT GROUP, INC. The principal address of the corporation is: 10526 West Sample Road, Coral Springs, Florida 33065.

The period of its duration is perpetual.
