to time in accordance with the Bylaws of the Corporation.

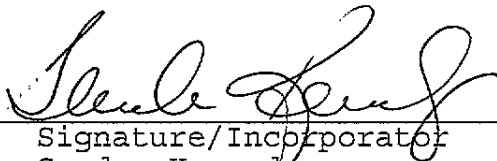
