**ARTICLE I. - NAME**

The name of this corporation shall be ED BUDA, INC.

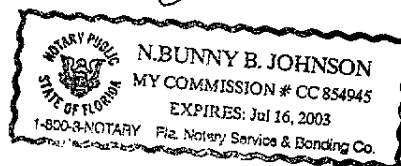
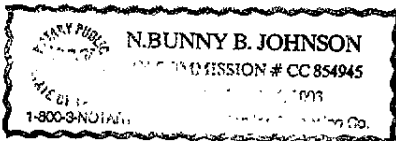
