

ARTICLES OF INCORPORATION

H. Theodore Simon Jr., Inc.



<u>ARTICLE I - NAME</u>

The name of this corporation is H. Theodore Simon, Jr., Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - COMMENCEMENT OF CORPORATE BUSINESS

This corporation requests the date of corporate existence of March 20th, 2002.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

Number. The aggregate number that the corporation shall have the authority to issue is 1,000 shares of common stock with a value of \$1.00 per share.

<u>Initial Issue.</u> One Hundred (100) shares of the common stock of the corporation shall be issued for the cash value of \$1.00 per share, 100 Shares being issued to H. Theodore Simon, Jr.

Stated Capital. The sum of the value of all shares of common stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.
