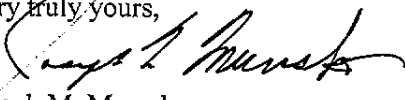

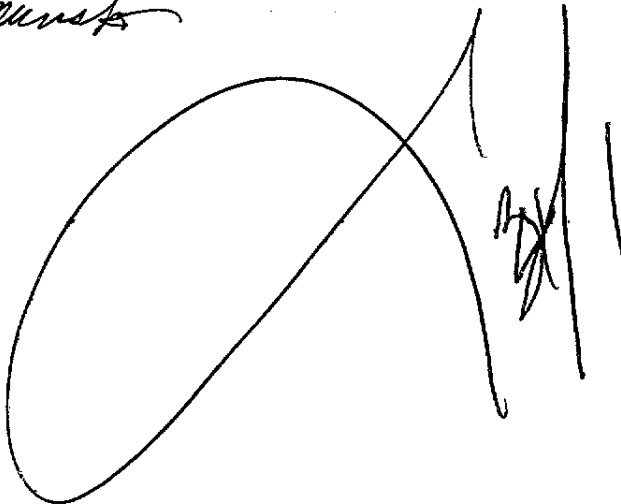

**ARTICLES OF INCORPORATION  
of

The undersigned subscriber(s) these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of this corporation is GATOR MOTEL.COM, INC.

**ARTICLE II. NATURE OF BUSINESS**

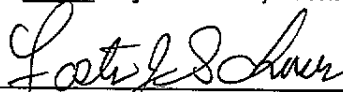
and all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

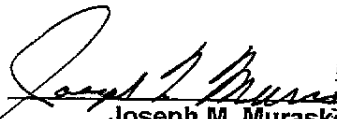
