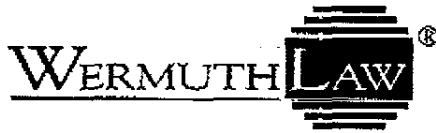

**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
PHARM-MED SERVICES OF SOUTH FLORIDA, INC.**

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of Pharm-Med Services Of South Florida, Inc. (the "Corporation") are hereby amended according to these Articles of Amendment:

The name of the Corporation is Pharm-Med Services Of South Florida, Inc.

FIRST: The name of the Corporation is changed from Pharm-Med Services Of South Florida, Inc. to S V's Pharmacy, Inc.

SECOND: The Amendment set forth in these Articles of Amendment was adopted on the date shown below.
