ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is BOWLING GIFTS BY BRI & DANI, INC.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue one class of shares, which should be called common shares.
