

ARTICLE I - NAME: The name of this corporation is LAKEWOOD CONSTRUCTION CORPORATION.

ARTICLE II - TERM: This corporation shall commence to exist on the time of the filing of these Articles of Incorporation by the Department of State of the State of Florida, and shall exist perpetually or until legally dissolved.

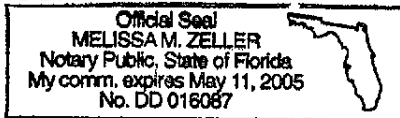
