ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MIAMI BEACH HOLDING COMPANY

- f 4. The number of shares voted in favor of such Amendment was one hundred (100), and the number of shares voted against such Amendment was none.
