

ARTICLES OF INCORPORATION

OF

ALE HOUSE LICENSING U.S.A. INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation is: ALE HOUSE LICENSING U.S.A.  
INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence unless dissolved pursuant to law and shall commence business as of the date of filing of these Articles of Incorporation.

PURPOSE


