**Article I – Name**

The name of the corporation is: Laurence G. Everly Flooring, Inc.

**Article II – Duration**

This corporation shall exist perpetually.

**Article III – Purpose**

This corporation may engage in or transact any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

**Article IV – Capital Stock**

The name and address of the person signing these Articles of Incorporation is: Laurence Gary Everly, 2169 Lake Dr., Winter Park, FL 32789.

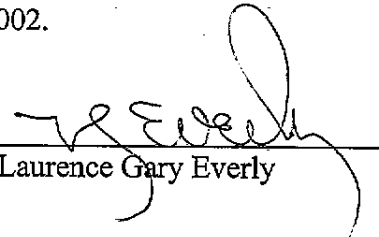
#### **Article IX – Initial Officers**

#### **Article X – By-Laws**

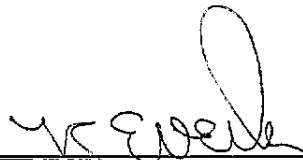

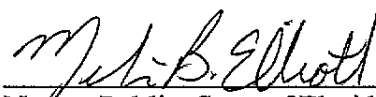

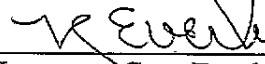
