ARTICLES OF INCORPORATION

OF

BAY COUNTY UNITED VENTURE, INC.

ARTICLE I - NAME:

The name of this corporation is: BAY COUNTY UNITED VENTURE, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Cleaning Services business and for the purpose of transacting any or all other lawful business not inconsistent with Laws of the State of Florida.
