

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A PROFESSIONAL SERVICE CORPORATION FOR PECUNIARY PROFIT UNDER THE PROVISIONS OF CHAPTER 621 OF THE FLORIDA STATUTES, HEREBY MAKES, SUBSCRIBES, ACKNOWLEDGES AND FILES THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I




