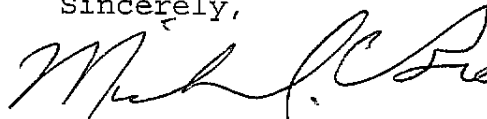

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is MARKER 57, INC.
