ARTICLES OF INCORPORATION
OF
B & R INTERNATIONAL AIRBOAT ACADEMY, INC.

ARTICLE I. - NAME

The name of the corporation is **B & R INTERNATIONAL AIRBOAT ACADEMY, INC.**
The address of the principal office of this corporation shall be 136 Hawthorne Road, S.E., Winter Haven, Florida 33884, and the mailing address shall be 136 Hawthorne Road, S.E., Winter Haven, Florida 33884.

ARTICLE II. - DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of the State of Florida.
