I DO FURTHER CERTIFY that at a meeting duly called for that purpose, on

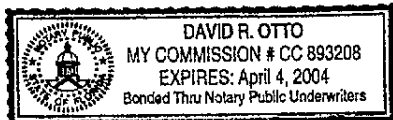
