THE UNDERSIGNED natural person, who is licensed and a Certified Architect the State of Florida hereby expresses the intention of forming a PROFESSIONAL CORPORATION in accordance with the Professional Service Corporation Act, and hereby adopts the following articles of incorporation for such Corporation:

ARTICLE I. NAME

The name of the Corporation is J. Stephen Cruz, P.A.

ARTICLE II. DURATION

The period of the Corporation's duration shall be perpetual or until dissolved on a vote of Shareholders as hereafter provided.

ARTICLE III. PURPOSE

The purpose of the Corporation is to furnish Commercial, Internal and Residential Architecture Services to public and private clients.

ARTICLE IV. CAPITAL STOCK

The total number of shares of Capital Stock which the Corporation shall be authorized to issue is 10,000 shares. Such shares shall be of a single class of Common Stock and shall have a par value of one dollar (\$1.00) per share.

On dissolution, the corporate property and assets shall, after payment of all debts of the Corporation, be distributed to the Shareholders pro rata, each Shareholder to participate in the distribution in direct proportion to the number of shares held by the Shareholder.


