ARTICLES - NAME

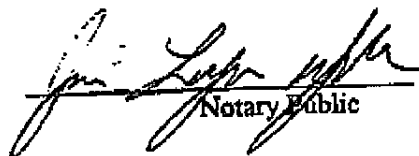
