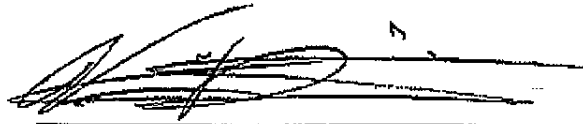
ARTICLE EIGHT
