ARTICLES OF INCORPORATION OF ASON NEUMAG CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Aracles of Incorporation:

ARTICLE I NAME

The name of the corporation is Ason Neumag Corporation (hereinafter called the "Corporation").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS
