The undersigned, acting as the incorporator of the Corporation under the Florida Business Corporation Act, adopted the following Articles of Incorporation for such Corporation:

**ARTICLE I**

**NAME OF THE CORPORATION**

The name of this Corporation shall be TREE OF LIFE RECORDS, INC.

**ARTICLE II**

**PERIOD OF DURATION**

The period of duration of the Corporation is perpetual.

**ARTICLE III**

**PURPOSE**

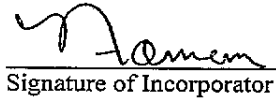

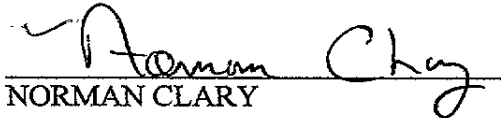
