The Name of the corporation shall be **REAGHALL INVESTMENTS, INC.**, whose principal office shall be located at 2131 Doral Drive, Tallahassee, Florida 32312.

The duration of the corporation shall be perpetual.

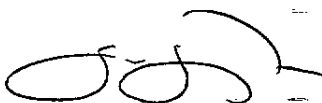
